#### CONSTRUCTION ON CRYSTAL VIEW APARTMENTS BEGINS

#### Ground Breaking and Business After-Hours Planned in Crystal Falls

The Hovey Companies is pleased to announce construction on the historic former Crystal Manor in downtown Crystal Falls is underway. Crystal View Apartments, a 25 unit one- and two-bedroom apartment community is

planned for completion in June of this year. The community will feature a fitness center, event and community room, historic décor, business leasing space, and two new immediately adjacent parking lots.

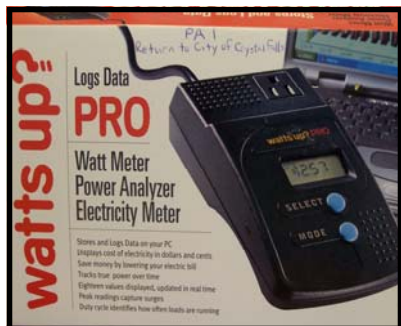

ON-LINE BILL PAY—COMING SOON: Technical difficulties have held up the implementation of on-line bill payments. There will be a small fee for use of the on-line bill payment system, however, if you would like to enroll in our Direct Payment program (you authorize us to pull the amount of your utility bill out of your checking or savings account each month) that service is free! The form to sign up for the Direct Payment program is on the back of this newsletter, just fill it out and return it to the City Clerk's office today!

**AUTHORIZATION FOR DIRECT PAYMENT**

I authorize the City of Crystal Falls to initiate entries to my checking/savings/loan account. This authority will remain in effect until I notify the City of Crystal Falls in writing to cancel it in such time as to afford a reasonable opportunity to act on it. I can stop payment of any entry by notifying my financial institution 3 days before my account is charged.
